

**Explanation:** This Resolution authorizes the Award of contract to Witmer Public Safety Group, Inc. for the purchase of Self-Contained Breathing Apparatus for Far Hills Bedminster Fire Department.

**WHEREAS**, on January 13, 2021 the Township received and opened One (1) bid in connection with the Self- Contained Breathing Apparatus with bid results as follows:

**WHEREAS**, by letter dated January 22, 2021, it is the recommendation of the Acting Purchasing Agent to award the Total Bid to Witmer Public Safety Group Inc. 104 Independence Way, Coatesville, Pennsylvania, 19320, in the amount not to exceed \$158,720.00.; and

**WHEREAS**, this contract has been awarded pursuant to a “fair and open process” pursuant to N.J.S.A. 19:44A-20.4, et seq.; and

**WHEREAS**, the Borough of Far Hills and the Township of Bedminster have an Interlocal Agreement Regarding Fire and Rescue Services wherein capital expenditures are apportioned 20% Far Hills and 80% Bedminster; and

**WHEREAS**, the contract for Self-Contained Breathing Apparatus was \$158,720.00, with Far Hills portion (20%) totaling \$31,744.00 and Bedminster’s portion (80%) totaling \$126,976.00

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Bedminster, in Somerset County, New Jersey, that the contract for the Bid for Self-Contained Breathing Apparatus be and hereby is awarded to Witmer Public Safety Group Inc. 104 Independence Way, Coatesville, Pennsylvania, 19320, in the amount not to exceed \$126,976.00.
